I agree to hold International Productions & Publications, Inc., the Ramada Plaza Denver North Hotel, the City of Northglenn, and/or the International and Colorado State Cinderella Scholarship Program & Pageant, its directors and staff members harmless of damages or liabilities due to theft, accident or injury during or resulting from any child's participation in the 2010 Colorado State Finals. I also accept the responsibility for the regulation of hours of personal activities on the participant. I understand and agree that should an act of God (hurricane, fire, tornado, or any other natural disaster) cause the cancellation of the 2010 Colorado State Finals, that said event will be cancelled without benefit of any refund; however the state finals will be rescheduled at another time and location. I also confirm that all of the enclosed information and forms are true and correct to the best of my knowledge and belief, including birth date and city of residence. I understand that any and all additional charges to my room during the Cinderella Finals (phone calls, valet service, room service, etc.) are my sole responsibility and hereby agree to pay such charges immediately upon checking out of the hotel. I hereby have read and understand the rules and regulations governing the payment of scholarship awards, and all other prizes and awards.

Also, if my daughter is one of the young ladies, who receives any crown (Overall, Beauty, Talent/Tot Personality, Photogenic or Cover Girl) or participates in Cinderella Girl, I give my permission for her picture and name to be used on the website, or in future advertising for the Cinderella Girl Program. If my daughter wins the Overall title in her age division (Tot-Teen), she agrees to attend 60% of the preliminary pageants during her reign. If she does not meet this requirement she understands that she will not receive her savings bond award.

I understand that if my daughter has to relinquish her title as Overall State Queen, she can not attend the 2010 Cinderella International Pageant, and/or can not attend the 2011 Colorado Cinderella State Pageant, her title will be forfeited, all awards will be returned and any monies due to the State Office will be paid back within two weeks. I also understand that my daughter will be suspended from the Cinderella program for at least one year.
